FACILITY INFORMATION



JULIE, Inc. (Joint Utility Locating Information for Excavators), is a not-for-profit corporation that provides professional excavators and homeowners with a free service to contact for the locating and marking of underground utility facilities. JULIE services the entire state of Illinois, except the city limits of Chicago. If digging inside the Chicago city limits, please contact DIGGER at 312/744-7000.

Our state-of-the-art call center facility is located at 3275 Executive Drive in Joliet, Illinois, approximately 30 miles southwest of the city of Chicago.

JULIE, also known as the Illinois One-Call System, was formed in 1974 by the owners and operators of underground utility facilities as a means of reducing damage to those facilities. JULIE serves as a message handling service for these utilities, taking information about planned excavations and distributing this information to its utility membership. ***JULIE staff does not locate any facilities.*** It is the responsibility of each utility to mark the location of their own underground facilities at the excavation site.
